Is resolving foreign element-related divorce case No. 67/2018/TLST-HNGD dated December 20, 2018 between:

Place of opening the mediation meeting and the hearing at the headquarters of Kien Giang Province People's Court, Vietnam (No. 08 Nguyen Cong Tru Street, Vinh Thanh Ward, Rach Gia City, Kien Giang Province, Vietnam).

The court hereby requests Mr. Chon, from the date of posting this document on the electronic information portal of Viet Nam Consulate General in San Francisco, State of California, USA until before the date of opening the hearing, Mr. Chon must send his opinions on the petition for divorce of the plaintiff- Mrs. Trinh Thanh Thao and attached documents and evidence (if any) to Kien Giang Province People's Court located at the addresss: No. 08, Nguyen Cong Tru Street, Vinh Thanh Ward, Rach Gia City, Kien Giang Province, Viet Nam.

Mr. Chon's signature on the documents made by Mr. Chon himself must be authenticated in accordance with the laws of Viet Nam. Documents must have been notarized in accordance with the

regulations of the country where Mr. Chon resides and the documents that are not issued and made by the competent authority of Viet Nam must be legalized before Mr. Chon sends them to the Court.

At the end of that period, if Mr. Chon fails to send his opinions together with the documents and attached evidence (if any) to Kien Giang Province People's Court, Viet Nam, the divorce case between the plaintiff, Mrs. Trinh Thanh Thao and Mr. Chon will be resolved in accordance with the laws of Viet Nam./.
